He/she is also able to properly argue possible solution, including multiple alternatives. - Very good 26-29: good knowledge of the topics, good properties 'of language, good capacity' analytical; the student is 'able to apply theoretical knowledge to real cases which are proposed to be analysed. EDUCATIONAL OBJECTIVES OF THE MODULE	
<p>The course aims at examining the nature, contents, and justifications of contemporary migration law from a theoretical and critical perspective. First, the course aims at understanding the philosophical and historical foundations of the state prerogative to regulate the entry of non-nationals on its territory. Second, the course aims at articulating the arguments pro and contra the claim that the state has the authority to restrict the aliens' entrance on its territory. Third, the course aims at reflecting on the philosophical grounds on which the category of citizenship is founded, and on the grounds to differentiate the treatment of citizens and aliens. In addition, the course aims at articulating the relationships between immigration law and human rights, the principle of equality and non-discrimination. The main objective of the course is providing students with tools and knowledge needed to grasp the norms and the policies governing contemporary migration. The concepts of citizenship, boundary, nationality, sovereignty, territory, are investigated with respect to their structural tension with the proclaimed universality of human rights. The way in which such tension has been worsened in the era of global migration is considered. Within this theoretical framework, an overview of the legal framework related to migration is provided. The parable of the right of asylum, as a right of access to rights for people who do not have, or who have lost, the protection of their own State, and ask for that of another one, is adopted as a privileged observation point. Peculiar attention will also be paid to the nature of complex phenomenon, such as trafficking and smuggling, and migrant labour exploitation, by looking at the efficacy of existing legal and policy framework in order to combat them.</p>
