PREREQUISITES	Scholastic knowledge of the artistic civilization of the Greek, Roman, Christian and Medieval world.
LEARNING OUTCOMES	<p>Knowledge and understanding: Acquisition of the contents of the discipline, with reference to the historical and artistic environment, to the material culture, to the settlement forms in the territory, in the period ranging from the dawn of the Greek civilization until the threshold of the early Middle Ages. Applying knowledge and understanding: Capacity to identify, examine and classify types and functions of architectural monuments, sacred and residential buildings, works of artistic handicraft and artefacts of common use, with the purpose to elaborate suitable interventions of restoration and conservation. Making judgements: During the course the opportunity to make personal reflections will be offered to the student with the aid of suitable bibliographic tools and a proper methodology, with the purpose to elaborate suitable interventions of restoration and conservation. Communication: The student, at the end of the course, will be able to communicate clearly and unambiguously about the archaeological context and /or about the monument in question, highlighting critically their features and using efficiently and with adequate mastery the specific vocabulary. For this purpose, during the course, will be tested the students' skill to communicate effectively within the group. Lifelong learning skills: The course aims to provide the students with the tools and the information to further study in the field in a personal and independent way.</p>
ASSESSMENT METHODS	<p>Student assessment is performed by oral exam, covering the topics of both modules: Classical Archaeology and Christian and Medieval Archaeology. The final evaluation of the Integrated Course, expressed in thirty-two, is given by the weighted average of the score reached by the student in the two modules. The student passes the exam if he has at least one score of 18/30 in each test. The evaluation will be formulated as follows:</p> <ol style="list-style-type: none">1) Basic knowledge of the topics covered and limited ability to elaborate acquired knowledge. Sufficient ability to analyze the topics presented. Limited autonomy for judging (rating 18-21).2) Good knowledge of the topics covered and good skills in compiling the acquired knowledge. Good ability to analyze the topics presented. Good autonomy for judging (rating 22-24).3) Extensive knowledge of the topics covered and more than good skills in the processing of acquired knowledge. Good analysis of the arguments presented. Autonomy of judgment more than good (rating 25-27).4) Excellent knowledge of the topics covered, excellent skills in compiling the acquired knowledge other than those of teaching . Excellent ability to analyze the phenomena presented. Excellent autonomy for judging (rating 28-30).5) Excellent knowledge of the topics covered, excellent ability to compile acquired knowledge other than those of teaching. Excellent ability to analyze the phenomena presented. Excellent autonomy for judging and showing the procedures followed (vote 30 and praise).

EDUCATIONAL OBJECTIVES OF THE MODULE

The course aims to trace an updated and complete picture of the figurative and architectural features of the Greek and Roman civilization, from the sixth century B.C. to the beginning of the fourth century A.D. The material culture and the modalities of the artistic production are going to be examined with reference to the specific historical and topographical context, so the students will obtain a suitable base education, in the light of the current research methodologies of the discipline. The value and the aims of the considered monuments are going to be explained every time within the cultural and social field of which they were expression.

EDUCATIONAL OBJECTIVES OF THE MODULE

The Christian and Medieval archeology studies the transformations of the ancient society between the Late Antiquity and the Middle Ages under the impulse of Christianity, in connection with the emergence of the first Christian cemeteries and religious buildings. The knowledge of urban and cemeterial topography and the study of the religious buildings, of the new iconographies and of the material culture, allows students to put in relation the archeology, the history and the socio-political events with the contemporary economic order of the Roman Empire between the Late Antiquity and the Middle Age. The proper knowledge of the iconographic and stylistic production, of the architectural and monumental language and of the handicraft production in the historical period in question has the purpose of allowing students to elaborate suitable interventions of conservation and restoration, with respect to the original appearance of each individual product or handicraft piece.
