ASSESSMENT METHODS	Oral examination on the general and on the specialized course. Students can take, according to the calendar of the University, ongoing checks whether oral or written. In the case of oral exam two questions will be arise on the program carried out in previous lessons. In case of ongoing written verification, the questionnaire will contain two questions on the program of the previous lessons. Ongoing checks may be taken into account for the final evaluation during examination of profit. The candidate must answer at least four questions posed orally, on the program, with reference to the recommended texts. The questions will range from the political thought of fairly modern age to the political thought in contemporary age.	
	At the request of the teacher, students will submit a paper for discussion in the classroom. The paper should be prepared in accordance with the methodology indicatedby the teacher during class and on a topic agreed with the teacher who must indicate bibliographical sources. Final assessment evaluates the acquisition by the student of knowledge and understanding of the topics covered in the curriculum, assesses its ability to operate a critical comparison between the thinkers or the currents study of political thought. The threshold of sufficiency will be achieved when the student is able to show his least thought and and understanding of the topics in general, when	
TEACHING METHODS	is able to show his knowledge and understanding of the topics in general, when is able to contextualize each thinker and is able to discuss basic aspects program (eg. conception of the State, governance). Below this threshold, the examination is insufficient. As, however, the candidate shows argumentative and expository skills, manages to expose with master topics in language program, able to interact with the examiner, demonstrates to have operated insights, to master the literature policy and program content, the more positive assessment is going up to excellence, with thirty cum laude.
