EDUCATIONAL OBJECTIVES OF THE MODULE

This module provides the student with an understanding and basic knowledge of the law and relevant ethical and legal procedures in clinical settings, with emphasis on electronic medical record and e-health. The student will also learn to read and understand his/her own professional profile as the primary juridical source at law and identify the essential elements of informed consent. Understanding the basic knowledge of the law and of the professional malpractice; Italian and european ethical guidelines.

The examination involves an oral test. The questions are intended to verify the duty of the legal professional of the practitioner (examples of questions: information requirements concerning the judicial authority, offenses concerning the person's unclear nature, the definition of professional secrecy, assumptions of the criminal liability, infomed consent The oral test will be evaluated in thirty (18 to 30 and praise)
