ASSESSMENT METHODS	The assessment will be a written examination. The written examination which will consist of a report on a video, must ascertain the possession of skills and subject knowledge provided by the course. The video will be specified during the last lesson. The report (2.200 - 2.500 words) should be both consigned during office hours and send by email to paola.miano@unipa.it at least 15 days before exam date (delivery for the first exam date in September is the 15th of July). Final assessment aims to evaluate whether the student has knowledge and understanding of the topics as well as he/she has acquired the capacity to interpret and independent judgment of concrete cases. The pass mark will be reached when the student shows knowledge and understanding of the subjects at least in general terms; he/she will also have presentation and argumentative skills as to allow the transmission of his/her knowledge to the examiner. Below this threshold, the examination will be insufficient. Grades are expressed in thirtieths.	
EDUCATIONAL OBJECTIVES	The course will address the different ways of write the report of a clinical interview and a clinical assessment in various contexts across the life span. The course will be taking into account the theoretical and methodological aspects and practical aspects. In particular, the course has the following aims: - to promote the knowledge of theoretical and practical elements with regard to clinical report; - to develop a greater autonomy of judgement; - to increase communication skills with regard to clinical report.
