LEARNING OUTCOMES	Knowledge and understanding skills. Knowledge of history epistemology. Educational elements of History. Relationship between epistemology, methodology and didactic history. Knowledge of the various types of sources of ancient, medieval, modern, contemporary history. Knowledge of the methodology of history, in particular the "method of proof" and "historical-critical method", and the historical evolution of this. Knowledge of methods and techniques of source exegesis. Knowledge of every possible form of valorisation of the documentary heritage for scientific, cultural, divulgative, tourist purposes, with particular attention to that concerning the history of Sicily. Ability to understand and master the methods of historical research. Ability to apply knowledge and understanding The ability to find, treat, analyze scientifically, preserve and enhance the historical sources of every type, with particular attention to the most recurring ones in relation to the history of Sicily. Ability to draw up short educational projects. Judging autonomy The student will have to be able to read, analyze and contextualize the sources of history and in particular to perform an exegesis with scientific methods and criteria, using in particular the "historical-critical" method and drawing a document card taken into consideration. In addition, he must be able to draw up synthetic projects for the enhancement of the Sicilian documentary heritage (exhibitions, publications, websites) and the didactic use of the sources. Communication skills The student should be able to fill in with scientifically adequate language the exegetic documents of the documents and with appropriate language dissemination texts to enhance the sources related to the history of Sicily and short projects of didactic laboratory. Learning Skills The student will have to acquire an autonomous capacity to operate through the sources of history, both to increase his / her knowledge, both to make known and to safeguard the heritage of his territory. In order to achieve this goal, there will be exercises of compilation of exegetic cards and design of initiatives for the enhancement of the documentary heritage.
ASSESSMENT METHODS	<p>The oral exam will be about two questions and discussion of some boards of written and unwritten sources and of educational projects previously drafted. Each of the two parts of the examination will affect the overall evaluation for 50%</p> <p>Knowledge and understanding will be verified through extensive questions on the epistemological, didactic and methodological issues. EDUCATIONAL OBJECTIVES	The course is designed to provide basic training on methods and techniques of historical research, the teaching of historical disciplines, the sources used by history and the possible forms of enhancement of the documentary heritage for scientific, cultural and tourist purposes. It also envisages the acquisition of practical skills related to the analysis of sources, the compilation of exegetic tabs, projects for the enhancement of the documentary heritage, and of didactic hypotheses. In the first part of the course the following topics related to general teaching will be illustrated in a basic way: the "curriculo", the "didattica per competenze", the "cooperative learning", the laboratory teaching, the use of the manual.
