The questions posed orally may regard any part of the course program, with reference to the recommended texts and scientific articles. The vote will take into account both the exercises performance and the final oral examination. The candidate gets the minimum evaluation if he/she has the basic knowledge of the topics covered in the course and demonstrates ability to autonomously organize the concepts. The final vote will be expressed in thirtieth and will be validated during the examination periods.</p> <p>Non attending students During the final exam students will answer 4 or 5 questions. The questions posed orally may regard any part of the program , with reference to the recommended texts and scientific articles. The candidate gets the minimum evaluation if he/she has the basic knowledge of the topics covered in the course and demonstrates ability to autonomously organize the concepts. The final vote will be expressed in thirtieth and will be validated during the examination periods.</p> |
| EDUCATIONAL OBJECTIVES | The course will provide the principal knowledge about core theories and methods in psychology of attitudes. The topics include definition, structures and functions of attitudes, the relation between attitudes and behavior, persuasion and prejudice |
| TEACHING METHODS | Lectures and practical exercises. The exercises will concern a) the individuation and the discussion of recent research that deepen the main theories covered during lectures and b) the production of a brief manuscript on the topic and the research discussed orally. Dates of the exercise will be agreed from time to time and will be communicated on the online platform http://elearning.unipa.it . The products of the exercises will be published on the same platform. |
