PREREQUISITES	Required is basic knowledge of the history of philosophy, with particular attention to the formation of subject idea in the modern age.

ASSESSMENT METHODS	Oral assessment The final oral assessment is a viva in which knowlwdge and skills in the field of study "Philosophical Ermeneutics" are going to be tested. They are: the acquisition of advanced tools for the comprehension of the texts, the in-depth knowledge of the historical period and the historical-cultural context in which the philosophies of Descartes and Pascal carry out their thinking action. Final pass marks go from 18 to 30 points cum laude. Non-attending students can arrange a modified program with the professor. The student is required to answer at least 2 or 3 oral questions regarding the whole program of study with reference to the suggested books. Questions shall assess a) the student's autonomous comparison with the philosophical text, knowlesge and understanding, the ability to organize their ideas in a coherent and appropriate way to the study context b) the ability to process and interpret critical issues of hermeneutic nature c) ability to communicate; d) making judgements. Despite the opposing outcomes of their perspectives, these two philosophers make the question of the will the test bed for a new idea of subject
TEACHING METHODS	Frontal teaching, Guided discussion on the proposed texts, seminars held by the student. The course adheres to the interdisciplinary project of the department titled "Reasons and Passions": the theme of will that will be the subject of the lessons can be considered an integral part of the question characterizing the project.
