PREREQUISITES	To understand the contents and the objectives of the course the student should be able to follow the argumentations debated by perceiving the cognitive challenges provided in the classroom by the lecturer. Beside this he/she has to interpret and develop the arguments explained in the textbooks properly.
LEARNING OUTCOMES	<p>Knowledge and ability of understanding. Acquisition of the basics of linguistics (with particular regard to the variational issues related to the Italian linguistic community) and of Italian dialectology.</p> <p>Ability to apply knowledge and comprehension. Ability to analyze linguistic, sociolinguistic and dialectological phenomena through the appropriate use of specialized concepts and terminology.</p> <p>Ability in autonomy of judgment. To be able to value the extra-linguistic implications, especially the social ones, of linguistic phenomena and the diatopic distribution of the main dialectal phenomena</p> <p>Communication abilities. Ability to expose the linguistic change and variation phenomena through theoretical arguments and examples from reality.</p> <p>Ability of learning. Ability of updating knowledge by reading scientific essays concerning variational linguistics and by attending workshops on sociolinguistic and dialectological topics.</p>
ASSESSMENT METHODS	<p>Before the oral exam, the student must take a written test aimed at demonstrating that they have acquired the fundamental notions of linguistics with particular regard to the variational and communicative problems relating to contemporary Italy.</p> <p>After the written test, the student must answer (in a oral exam) at least three questions about the whole programme and the themes dealt with in the works included in the reading list.</p> <p>The exam (written and oral) aims at assessing if the student knows and understands the topics he/she has been asked, if he/she is able to make judgments on cases provided by the lecturer and if he/she has reached the expected targets.</p> <p>The exam score is awarded by a vote expressed in 18 (min.)-30 (max) The exam is passed if the student knows and understands the topics dealt with in the course at least in general terms, and if he/she has minimal application skills to solve concrete issues. Moreover, he/she must have speaking and arguing abilities in order to communicate the lecturer his/her knowledge. Below this threshold, the exam will be considered failed. The more the student is able to interact with the lecturer through his/her communicative skills, to show a detailed knowledge of the topics dealt with, autonomy in judgement and ability to apply knowledge, the more the assessment will be positive.</p>
