LEARNING OUTCOMES	<p>SOCIOLOGY OF THE FAMILIES (C.A.) -----</p> <p>Knowledge and understanding: Knowledge and understanding on family changes and on the links between economic and welfare system. Applying knowledge and understanding: To understand family policies and the Italian welfare Communication skills: Developing communicative-relational skills clearly and with proper arguments. Learning skills: Using the theoretical and methodological tools acquired by being able to understand the links with the social context</p> <p>NARCISISM AND SOCIAL RELATIONSHIP -----</p> <p>Knowledge and understanding: Knowledge and understanding of social relations and the functioning of social organizations in relations also with the global economy; Knowledge and understanding of narcissism as a personality disorder and as a useful concept to understand some relational, cultural and identity dynamics of contemporary society. Ability to apply knowledge and understanding: Ability to analyze and understand the transformations of the contemporary capitalist economy and the socio-anthropological changes it has determined on personal and social identities and relational dynamics; In particular the transformations of the individual sphere increasingly oriented to an individualistic and self-referential dimension. Autonomy of judgment: Being able to evaluate critically and autonomously the socio-cultural transformations of contemporary capitalism and the parallel development of an individual increasingly absorbed by consumerism, also through the diffusion of technologies and social networks, which becomes a mode of acting social relationships through the derives from the narcissists at the time indicated by Christopher Lasch. Communication skills: Ability to expose the main sociological theories and the reflections of some individual authors on the transformations of contemporary societies in the era of global capitalism. Being able to argue about cultural transformations in a society where the economy is increasingly dominated by individual relationships and socio-cultural patterns. Learning ability: Ability to understand the changes of society and the contemporary economy and to observe the socio-relational transformations in the age of narcissism (Lasch and Cesareo). Ability to read specific scientific publications and reflections on narcissism as a psychological and social phenomenon.</p>
ASSESSMENT METHODS	<p>Class test in progress and final oral examination. Oral exam - Grades on a scale between 18 and 30 cum laude. The exam consists of an interview aimed to check the level of knowledge of the topics in the syllabus, the level of familiarity with the specialized language and the ability to develop a reasoning aimed to the application of theoretical knowledge to specific cases. The interview consists of a minimum of two/three questions. The evaluation will follow the grid below:</p> <ul style="list-style-type: none"> - Excellent (30 - 30 cum laude): great knowledge of the topics, excellent language skills, excellent capacity of analysis; the student is able to brilliantly apply theoretical knowledge to real cases. He/she is also able to properly argue possible solution, including multiple alternatives. - Very good (27-29): good knowledge of the topics, very good language skills, good capacity of analysis; the student is able to properly apply theoretical knowledge to real cases. - Good (24-26): good knowledge of the main topics, good language skills, the student shows adequate ability to apply theoretical knowledge to real cases. - Satisfactory (21-23): the student does not show a complete command of the main topics, although showing the knowledge of the basic ones; he/she shows satisfactory language skills and a quite satisfactory ability to apply theoretical knowledge to real cases. - Sufficient (18-20): minimal knowledge of the main teaching and technical language issues, limited capacity to adequately apply theoretical knowledge to real cases. - Insufficient outcome: the student does not have an acceptable knowledge of the contents of the various topics on the syllabus

EDUCATIONAL OBJECTIVES OF THE MODULE

Through the analysis of classical and contemporary sociologists' works, the course aims to illustrate the relationship between capitalism, individualization process, narcissism and contemporary society, starting from the pioneering work of Christopher Lasch "The culture of narcissism" (1979). The main objectives are to provide adequate keys to understand: the changes of the individual and his identities; the transformations of (and in) contemporary social relationships, trying to identify which causal factors of the dominance of global capitalist economy - also from the point of view of the cultural dynamics involved - influence the relational dynamics and how they intertwine with narcissism, not only considered as a personality disorder, but mainly as an anthropological drift resulting from different structural and cultural changes in society; how the individual and groups are increasingly characterized by self-referential and fragmented identities, totally absorbed in the "hic et nunc" and therefore lacking in consciousness and historical memory and what impacts all these processes have on the various forms of social bond.
