<b>PREREQUISITES</b>	Basic knowledge of historical, institutional, economic and legal foundations of Italian and European Law.
<b>LEARNING OUTCOMES</b>	Knowledge and ability of comprehension. Full comprehension of the comparative method. Capability of adopting understood knowledge and comprehension. Ability to compare different legal experiences with particular regard to the different legal sources. Comprehension of the foreign idiomatic languages and improvement of communicative capability. Knowledge of the main features of the english common law, with particular reference to contract law.
<b>ASSESSMENT METHODS</b>	The student's assessment involves an oral test, consisting of an interview in which questions are asked about subjects included in the course program. The exam tends to assess whether the student has knowledge and understanding of the subjects, has acquired interpretative competence and autonomy in the assessment of concrete cases. The interview consists of a minimum of three questions.
<b>EDUCATIONAL OBJECTIVES</b>	Enabling students to have access to different legal systems (and in particular to the English Common Law) and be able to manage them so as to operate as a professional (judge, lawyer, civil servant) in a foreign country. The second part of the course is devoted to an introduction to digital markets and the main legal issues connected to their rise.
