ASSESSMENT METHODS	Oral exam. The student must answer from three to five questions concerning all the topics
	in the program. The assessment aims to evaluate if the student shows mastery
	of the program, property of language and ability to apply the acquired
	knowledge to specific problems. Evaluation methods
	The result of the test will be considered:
	- excellent (30-30 cum laude), if the student shows excellent knowledge of the topics, excellent property of language, good analytical capacity and the ability to
	apply the acquired knowledge to solve the submitted problems;
	<ul> <li>very good (26-29), if the student shows good mastery of the subject, full property of language and the ability to apply the acquired knowledge to solve</li> </ul>
	the submitted problems;
	- good (24-25), if the student shows to have basic knowledge of the main topics, fairly good property of language, limited ability to autonomously apply the
	knowledge for the solution of the submitted problems;
	- more than sufficient (20-23), if the student shows not to have full mastery of the main arguments but a good understanding of the same, satisfactory property
	of language, poor of ability to independently apply the acquired
	knowledge;
	- sufficient (18-19), when the student shows minimum basic knowledge of the main topics and of the technical language, minimum ability to apply the acquired
	knowledge;
	- insufficient, if the student does not have an acceptable knowledge of the contents proposed in the Course.
EDUCATIONAL OBJECTIVES	The Course aims to trasmit the basic knowledge concerning Economics applied
	to intermediate systems (in Italian doctrine, "Economia delle amministrazioni
	aziendali" or, more commonly "Economia aziendale"). It also provides the basic knowledge useful in Accounting for the control.

	professional knowledge". Especially, the Course deals with:
	- contexts and contents of economic activity and administration;
	- organization, management and accounting control characteristics of "aziende";
