PREREQUISITES	Required is basic knowledge of the History of Philosophy, with particular attention to the history of the relationship between philosophy and religion.

ASSESSMENT METHODS	ONGOING EVALUATION Oral assessment: The oral assessment is a viva in which knowledge and skills in the field of study are going to be tested. Final notes go from 18 to 30 points. The student is required to answer at least 2 or 3 oral questions regarding the whole program of study with reference to the suggested books. Questions shall assess a) the student's autonomous comparison with the philosophical text, knowlesge and understanding b) cognitive and practical skills c) ability to communicate; d) making judgements. EDUCATIONAL OBJECTIVES	Aim of the course titled "Reason from the point of view of religion" is to help the student to understand that relationship between philosophy and religion can not be based on an opposing logic that sees religion as an alternative to the faith, and can instead refer to a conciliation. This is of particular interest to the whole training course described in the degree program in Education Sciences, as it provides a theoretical basis for addressing the issue of religious pluralism within institutions, hospitality structures ans schools.
