DOCENTE: Prof.ssa MANOELA PATTI PREREQUISITES Basic knowledge of modern and contemporary history is an essential prerequisite, as well as a basic knowledge of geography. **LEARNING OUTCOMES** Knowledge and understanding: Students will acquire knowledge and understanding of colonialism history from a global perspective. Students will acquire knowledge of the process of creating the "colonial world" in a global perspective; the main focus will be on colonization, decolonization and globalization and Italian colonialism. Applying knowledge and understanding: At the end of the course, students will become acquainted with key theoretical elements characterizing the historiographical debate on the theme. Making judgements Students shall acquire: the self-confidence in undertaking self-directed learning and in making the most effective use of time and resources; the knowledge and the understanding of some key and much-debated problem areas of history, in particular the analysis about the colonialism and the decolonization, the forms of hybrid culture and transnational connections, global and local links, historical processes that characterize the global perspective in colonial studies; the ability to draw connections between diverse perspectives in the framework of the complex global exchanges; the ability to analyze critically the role played by colonizers and colonised societies; the capacity to engage in effective critical inquiries by defining problems, gathering and evaluating evidence, and determining the adequacy of argumentative discourse. Communication skills: Students shall engage in discussion concerning the history of colonialism and imperialism, and be able to present independent opinions by using arguments that are clearly expressed, coherently organized and effectively supported by relevant evidence. Learning skills Acquiring a broad range of historical knowledge and understanding, including a sense of development over time, critically evaluating the significance and utility of a large body of material, including evidence from sources and the opinions of Students are expected to achieve a deep historiographical analysis of the key issues developed during the lessons (periodization; cultural interaction; global and local; region and areas; race and ethnicity; people and goods movements; imperialism; etc...). ASSESSMENT METHODS Final oral assessment: The oral assessment is a viva in which knowledge and skills in the field of study are going to be tested. Final notes go from 18 to 30 The student is required to answer at least 3 or 4 oral questions regarding the whole program of study with reference to the suggested books. The perspective adopted will be global; special attention will be devoted to the issue of colonialism and Imperialism. The course will tackle some theoretical and methodological aspects concerning theories and concepts about colonialism and imperialism. The lessons will explore issues such as race, gender, culture, migration, political and cultural institutions, environment, economic and social

contexts, and structures. The course, also, will focus on the role played by war and violence in creating colonial empires. Finally, part of the course will be devoted to the history of Italian colonialism. It will be a focus on the fall of colonial empires, analysing the key milestones of the decolonization process. Readings and discussions will focus on various cultural products of the colonial

	world, looking both and at colonizers' societies, and at the colonized ones, focusing on their complex encounters.
TEACHING METHODS	Traditional lectures, guided discussion on the proposed texts, seminars. Students are required to take part in class discussions and to use a historical atlas or maps.
