PREREQUISITES	Students should have previous knowledge of general foundations of the constitutional system
LEARNING OUTCOMES	<p>Knowledge of</p> <p>The course aims to introduce students to current legal models and new strategies against crime. For criminal procedural law, particular reference will be made to the Constitution, the main international sources, the current Code of Criminal Procedure, and the most relevant complementary legislation.</p> <p>Capacity to apply knowledge and understanding</p> <p>At the end of the course, students will critically review topics in order to develop competent points of view on criminal policy strategies currently proposed in Italy and Europe to fight crime. Ability to apply the foundational principles of the criminal justice process, the strengths of the system, and the general principles of the system when interpreting procedural rules and when reading case law and application practices.</p> <p>Being aware of the topics</p> <p>The course will provide students with appropriate tools to assess legal models against crime.</p> <p>Communicative skills</p> <p>The course will dedicate emphasis on the "law in action". Controversial cases will be examined, as well as practitioners will be involved in some meetings. Students are expected to deal in a technical language with some practical cases and to present the results to a non-expert audience. In addition, they will be aware of the social consequences of criminal law.</p> <p>Learning capacity</p> <p>Awareness of students on the public debate concerning criminal law will be addressed.</p>
ASSESSMENT METHODS	<p>Oral final exam and in itinere test.</p> <p>By means of the oral test, students will be assessed on their knowledge and skills. Final mark will be given out of 30.</p> <p>Through exam questions, both opened and semi-structured, it will be evaluated on: 1) level of understanding; 2) ability to link the contents of the course; 3) communicating skills.</p> <p>In particular, it will follow this evaluation model.</p> <ul style="list-style-type: none">- Excellent (30-30 with honors): excellent knowledge of criminal law and procedure.- Receptive and expressive language skills, excellent analytical capacity. Students are able to apply knowledge and solve problems.- Very Good (26-29): good knowledge of concepts, good language skills, capability to solve controversial issues.- Good (24-25): Basic knowledge, discreet language, ability to independently apply the knowledge to the solution of the proposed problems.- Satisfactory (21-23): the student has not fully mastered the concepts, but has minimum level of understanding; satisfactory language; limited ability to apply the knowledge.- Sufficient (18-20): minimum basic knowledge and language skills; poor ability to independently apply the knowledge.- Inadequate - the student does not have a basic minimum knowledge of contents.
