LEARNING OUTCOMES	During the lessons, students will be stimulated to intervene to discuss the various issues analyzed by linking them to historical-cultural contexts. Strengthening of the tools of interpretation of a classic of philosophy in relation not only to its argumentative construction but also to the circumstances of its production, to the tradition of thought in which it is inserted, to the programmatic intentions of the author.
ASSESSMENT METHODS	The way in which the actual acquisition by students of the expected learning outcomes is ascertained is an oral test.  Unit of measurement used: thirtieths. Starting from the grade of 18/30, awarded when the knowledge / skills of the subject are at least elementary, up to the grade of 30/30 with possible honors, when the knowledge / skills are excellent. Description of assessment methods:  30-30 cum laude: excellent knowledge of the topics, excellent language skills, good analytical skills, the student is able to apply the knowledge to solve the proposed problems;  26-29: good command of topics, full ownership of language, the student is able to apply knowledge to solve the proposed problems;  24-25: basic knowledge of the main topics, fair language properties, with limited ability to independently apply knowledge to the solution of the proposed problems;  21-23: the student does not have full mastery of the main teaching topics but possesses the knowledge of them; satisfactory language property; poor ability to autonomously apply the acquired knowledge;  18-20: minimal basic knowledge of the main topics of teaching and technical language, very little or no ability to independently apply the acquired knowledge insufficient: does not have an acceptable knowledge of the contents of the topics covered in the teaching. EDUCATIONAL OBJECTIVES	The course aims to analyze the origin and evolution of Islamic speculation following the reception of the Greek philosophical heritage from the eighth century to the twelfth century. During this period Islamic reflection, detaching itself definitively from the Greek matrix, will be oriented in theological sense, assuming the characteristics of an orientation that will develop in the so-called philosophy of enlightenment (ishraqi). Students will be provided with the tools to understand this process of reception and re-reading, which must also be framed from the historical point of view.
TEACHING METHODS	The course is organized in lectures (or in telematic mode).
