ASSESSMENT METHODS	<p>Oral examination. aimed at ascertaining the level of knowledge of the subject matters. The exam consists of a minimum of three questions. The evaluation will unfold as follows: Excellent (30 - 30 cum laude): good knowledge of the topics, excellent language skills, excellent capacity of analysis; the student is able to apply theoretical knowledge to real cases which are proposed to be analysed. Very good (26 - 29): good knowledge of the topics, good language skills, good capacity of analysis; the student is able to apply theoretical knowledge to real cases which are proposed to be analysed. Good (24 - 25): Basic knowledge of the main topics, good language skills, the student shows limited ability to apply theoretical knowledge to real cases which are proposed to be analysed; Satisfactory (21 - 23): the student does not show complete conceptual mastery of the main teaching topics, although showing to know the basic knowledge; he/ she shows satisfactory language skills albeit with a poor ability' to adequately apply theoretical knowledge to real cases which are proposed to be analysed; Sufficient (18 - 20): minimal knowledge of the main teaching and technical language issues, limited or no capacity to adequately apply theoretical knowledge to real cases which are proposed to be analysed; Not sufficient: the student does not have an acceptable knowledge of the contents of the various topics on the agenda.</p>
