PREREQUISITES	Students must know the most important theories of public communication, the different models of journalism and the history of the interaction between politics,
	media and citizens in Italy.
LEARNING OUTCOMES	KNOWLEDGE AND CAPACITY OF UNDERSTANDING Gain knowledge and understanding of the main circuits of institutional communication in Italy: involved social actors, channels and discursive strategies. CAPACITY TO APPLY KNOWLEDGE AND UNDERSTANDING The course aims at developing the students' capacity to use peculiarities of the "institutional language", making reference to the transformations of Italian laws. INDEPENDENT JUDGEMENT Ability to develop independent judgments on the effective impact of public communication campaigns, focusing on the evolution of the interaction between citizens aand institutions in Italy. COMMUNICATION SKILLS Through the presentation and discussion in class of case studies the student will gain a specific language required by the course, strengthening the communication skills both on a written text and an oral presentation. LEARNING ABILITY The course aims to develop the students' awareness and critical reading ability in order to undertand the evolution of the information right in Italy.
ASSESSMENT METHODS	The assessment methods include written examinations aiming at ascertaining the possession of knowledge and understanding of the course topics as well as critical competences of the student. ASSESSMENT METHODS: the result of the examination will be considered: EXCELLENT: (30-30 e lode) if the student has excellent knowledge of the proposed topics, very good analysis and is able to apply the competences to concrete cases; VERY GOOD (26-29): if the student has very good knowledge of the proposed topics, good analysis and is able to apply the competences to concrete cases; GOOD (24-25): if the student has a basic knowledge of the proposed topics, a limited autonomy in analysis and is partially able to apply the competences to concrete cases; SUFFICIENT PLUS (20-23) if the student has an incomplete knowledge of the main topics but he shows to know them at a sufficient level; very low competence to apply the studied knowledges; SUFFICIENT (18-19) if the student has a very low basic knowledge of the main topics, of the specific language of the discipline and very low competence to apply the studied knowledges; NOT SUFFICIENT: if the student hasn' t an acceptable knowledge of the topics of the discipline
EDUCATIONAL OBJECTIVES	The course aims to develop knowledge of the main theoretical approaches of public communication, focusing on the evolution of the interaction between State and citzens in Italy. It will present and analyse the theme of the visibility of power in the media age history, as well as the connection to the birth of modern journalism in the democratic systems and contemporary populisms.
TEACHING METHODS	Lectures using multimedia aids.
