The progressive assessment test consists in 16 multiple-choice questions on the concepts of the discipline that have already been discussed in class before the break. For each correct answer a score of 1 is assigned, for a maximum total score of 16. Wrong answers are not evaluated. The final written exam consists in 16 multiple-choice questions on the key concepts of the discipline that will be discussed in class after the progressive assessment test. Answers will be evaluated in the same way as the progressive assessment test. Final marks correspond to the sum of the score obtained during the progressive test plus the score obtained at the final exam. Scores above 30 will be converted to 30 plus lode (honors).
