PREREQUISITES	A good synchronic knowledge and an at least elementary diachronic knowledge of ancient Greek and Latin, enabling Students to understand textual examples and to discuss problems
LEARNING OUTCOMES	<p>Knowledge and understanding</p> <p>Students, provided with a good knowledge of the classical languages, will be trained in the examination of problems and methods of classical philology, in view of a critically conscious reading of the ancient texts. They will be introduced to understanding the history of Greek and Latin texts and using critical editions as well as to formal analysis of factors that are important in order to establish a critical text.</p> <p>They also will be enabled to expand their knowledge of some basic issues such as the genesis and evolution of alphabets in their relationship with the ancient pronunciation, without neglecting local dialect peculiarities (especially for Greek) and the aspects of morphology and syntax that are involved.</p> <p>A constant attention to the ancient linguistic practices will be guaranteed by the consultation of inscriptions and papyri, while readings of literary passages taken from modern editions of the classics, will help Students to check continuities and discontinuities between the ancient writings and the modern edition.</p> <p>Applying knowledge and understanding</p> <p>These skills will be exercised during the reading and discussion of the formal problems found in the texts.</p> <p>Making judgements</p> <p>Readings guided by the professor will be discussed during the course and reference will be given to the most authoritative works, in order to enable Students to continue their own analysis,</p> <p>Communication</p> <p>The Student will be able to communicate, both orally and in writing, in Italian or, if on his own free choice, in Latin all the information related to the methodological and critical acquisitions reached during the course, as well as' interpretations developed during the reading of the texts. Communication skills will be tested in the examinations.</p> <p>Learning ability</p> <p>At the end of the course the Student will be in possession of solid basic knowledge in the field of the present discipline, of autonomous capacity for critical re-elaboration in the use of the acquired tools, of the faculty of identifying and elaborating in-depth study paths both of the texts examined within the annual program and of other texts, also belonging to different literary genres.</p>
ASSESSMENT METHODS	<p>Oral examination. For the purposes of the evaluation, three aspects will be considered: knowledge of the rules and the method of classical philology; Ability to apply that knowledge to the discussion of examples; Knowledge of the diachronic development of the method. The following marks will be used: 30-30 and praise: excellent - the mark given in case of excellent treatment of the three aspects; 27-29 - Distinguished - the mark given in case of limited imperfections in the treatment of one of the three aspects; 24-26 - Good - the mark given in case of widespread uncertainty; 21-23 - discreet - the mark given in case of incomplete or partially inadequate discussion; 18-21 - the mark given in case of a satisfactory balance of the answers by the candidate - sufficient; (<18) - insufficient / to be repeated - outcome of the examination in case of widespread deficiencies found on several aspects of the candidate's knowledge.</p>
EDUCATIONAL OBJECTIVES	<p>Contributing to a solid basic training of the Students allowing them a conscious approach to the ancient text, via structured information on its transmission through the centuries and cultures that separate us from the age of the author, and the discussion of uncertainties that may arise from the limits of its tradition (corruptions, omissions, any remakes or later modifications). In particular offering the possibility of learning methods useful in the evaluation of textual problems and of their consequences on the interpretation of various types of works,</p> <p>Becoming able to discuss such questions independently and to submit their own conclusions, also through use of the tools provided by the critical edition.</p> <p>Showing which cultural and exegetical tools can be useful when interpreting ancient texts, including the most important bibliographic databases and computerized resources.</p>
