PREREQUISITES	A good synchronic and diachronic knowledge of ancient Greek and Latin, such as to allow correct reading of ancient documents even when palaeographic difficulties are present. A good knowledge of the principles of classical Philology (for whose acquisition the course of Institutions, held during the same year at the first semester, can be useful). An elementary knowledge of computing and of some applications of its (word processing, using the browser).
LEARNING OUTCOMES	Knowledge and understanding The Student, already in possession of a good knowledge of classical languages and of the principles of classical philology, will be trained in the reading of ancient and medieval witnesses of the works of classical antiquity (papyrus, codices and, if possible, epigraphs), aimed at the collation of the texts and at their verification. He will be introduced to the history of Greek and Latin texts and to the use of critical editions, as well as to the analysis of the formal factors that contribute to the constitution of the texts. At the same time he will be trained to codify, process and discuss the information acquired from the ancient documents, making use of the current informatic methods for finding, processing and publishing the texts. Applying knowledge and understanding These skills will be exercised when reading and discussing the formal and substantial problems encountered in the texts. Making judgments In the passage from reading the documents to discussing their edition the Student will have the opportunity to refine his critical skills by getting used to considering the texts of ancient authors not as a simple certitude, but as the result of an intellectual elaboration, as both readers and researchers are never to forget. Communication skills The Student will be able to communicate, in oral and written form, in Italian and in Latin (at least in the "Latin of apparatus"), all the information acquired from the comparison of the documents and from the consultation of the editions. The development of communicative abilities will benefit from the synergy and contrast between the traditional ecdotic and the modern digital ecdotic of the texts. The communicative abilities in question will be verified during the examinations. Learning ability At the end of the course the Student will be in possession of solid basic knowledge in the field of the present discipline, of autonomous capacity for critical re-elaboration in the use of the acquired tools, of the faculty of identifying and
ASSESSMENT METHODS	Oral examination. For the purposes of its evaluation two aspects will be taken into account: the ability to read and transcribe texts; the ability to relate ancient or medieval witnesses to existing critical editions to assess their quality, accuracy and to discuss them. There will be a preliminary ongoing test aimed at ascertaining the acquired computer skills. The following points are in use: 30-30 cum laude: excellent - point attributed in the case of an excellent treatment of the two aspects; 27-29 - distinct - point attributed in the event some imperfections should emerge in the treatment of one of the two aspects; 24-26 - point attributed in the case of more widespread uncertainties; 21-23 - fair - point attributed in the case of an incomplete or partially inadequate discussion; 18-21 - point attributed in the case of an acceptable balance between knowledge and lack of knowledge - sufficient; (<18) - insufficient / rejected - outcome of the examination in the case of widespread deficiencies found on more aspects of the candidate's knowledge. The final grade will be weighted as follows: 30% for the ongoing test; 70% to the final exam.
EDUCATIONAL OBJECTIVES	Contributing to a strong Student training by enabling a conscious approach to ancient text, through the direct access to documents and the direct observation of the transmission of the text through the centuries and cultures that separate us from the author's age. Discussing the decisions that a critical editor can adopt facing the limits of tradition (mistakes, omissions, reworking / reviews). In particular, practicing the methods used to evaluate textual issues and their reflections on the interpretation of works of various typology, using the complex information acquired from documents and editions.
