EDUCATIONAL OBJECTIVES	The concept of enunciation is usually associated with certain tutelary deities of contemporary linguistics and semiotics. Not surprisingly, bibliographies on the subject are filled with references to the works of linguists such as Émile Benveniste and Antoine Culioli, or to essays by semioticians such as Algirdas Greimas and Joseph Courtès. Yet, the history of ideas in the 20th century shows with clarity and richness of examples that semiotic-linguistic reflection on enunciation is only a part of the studies on the subject. In fact, philosophically inspired reflection has been grafted onto the same topic and has been able to engage in fruitful dialogue with the main instances of semiotic-linguistic discourse. A thin red thread, in this sense, runs through the texts of important thinkers who have been among the authors of this dialogue: Michel Foucault, Jacques Lacan, Jacques Derrida, Gilles Deleuze and Félix Guattari, just to mention the most important names. The class aims to delineate the identikit of a plural philosophy of enunciation that has its germs in the above-mentioned figures and that today transpires with increasing evidence in certain significant articulations of contemporary debate.
