<b>LEARNING OUTCOMES</b>	<p>Knowledge and understanding the main preventative strategies that can be implemented for the reducing the burden of morbidity in the workers.</p> <p>To possess, moreover, knowledge on the main topics of Legal Medicine, with particular reference to liability issues professional, informed consent, privacy, ethics and deontology.</p> <p>On the basis of the knowledge acquired, to be able to deal with the emerging medical-legal issues in offering assistance, in the planning and management of staff in the health area.</p> <p>Ability to apply knowledge and understanding</p> <p>Know how to correctly assess health problems and provide adequate advice to workers taking into account risk factors (physical, chemical, biological, work-related stress, etc.).</p> <p>Being able to perform basic diagnostic procedures and techniques of occupational medicine, knowing how to analyze and interpret the results, at the in order to correctly define the nature of a problem.</p> <p>To know the basis for making correct decisions when necessary, in health care issues and define the features of professional practice based on different scientific evidence.</p> <p>Understanding how to interface with the basic organization of systems health care, based on knowledge of the different skills and responsibilities of health service providers, being aware of how these are the result of deep interactions with policies, organisation, financing and health care management.</p> <p>Autonomy of judgment</p> <p>Acquire the ability to integrate the knowledge gained in the field of prevention applied to workers' health, being able to make critical judgements based on information on possible exposures to risk factors in the workplace. Dealing with medical-legal issues on your own, relating to professional responsibility in general and specifically, and the criteria identifiers in the allocation and areas of individual responsibility and in the teamwork.</p> <p>Communication skills</p> <p>Know how to communicate clearly the problems of prevention and health promotion to the individual worker and knowing how to interact with other figures professionals involved in patient care through teamwork efficient and multidisciplinary.</p> <p>Know and communicate the characteristics of the guidelines, levels of evidence and the strength of the recommendations and the differences between guidelines, protocols, procedures, recommendations, therapeutic diagnostic pathways and their value in the criminal judgment.</p> <p>Learning capacity</p> <p>Being able to collect, organize and interpret correctly the health and biomedical information of the different documents (DVR, data of health surveillance, etc.) and available databases.</p> <p>Know how to use the technology associated with information and communications as the right support for diagnostic, therapeutic and preventive practices.</p> <p>Ability to update one's knowledge of the psychological elements, sociological, anthropological, philosophical, theological, legal-legislative, as well as scientific basis for bioethics.</p>

### EDUCATIONAL OBJECTIVES OF THE MODULE

The Legal Medicine module aims to provide training that allows the graduate to:

- coordinate simple and / or complex healthcare organizations using the main topics of Legal Medicine geared towards problems, with particular reference to problems concerning professional responsibility, informed consent, drugs administration and patient restraint, privacy, as well as deontological rules, relations with the Judicial Authority and the main legal obligations, of public and private healthcare currently in force in Italy and in the European Community;
- know the health organization in Italy according to the articulation of the National Health Service with the different regulations that over time have led to the current structure;
- analyze the fundamental obligations for health professionals, mandatory communications to the Authority Judicial and health care, the custody of professional secrecy, the protection of patient privacy and consent informed of the assisted person;
- take care decisions consistent with the legal, ethical and deontological dimensions that govern the organization health and professional responsibility;
- critically analyze the ethical and deontological aspects of the professions in the healthcare area, also from a perspective of multi-professional integration;
- know the principles of public law and administrative law applicable to relations between administrations and users involved in health services;
- operate in compliance with the main legislative regulations governing the healthcare organization, as well as with the regulations ethical and professional liability.

**EDUCATIONAL OBJECTIVES OF THE MODULE**

The module aims to provide students with basic knowledge on the subject, with a particular focus on institutions and state bodies, with reference to the division of state and regional skills in health.

The student, at the end of the course, will have acquired the fundamental notions in the legal field on the system of sources and on the use of regulatory tools in health. In addition to the acquisition of basic knowledge about public law institutions, a relevant part of the module is aimed at providing the student with a detailed knowledge of the national health organization and its legislation.

At the end of the course, the student will have acquired appropriate training on the constitutional charter and, in particular, on the fundamental principles, the rights and duties of citizens, as well as on the rules that govern the protection of the right to health.

He should be able to identify issues of legal interest in health care, with particular reference to informed consent and professional health liability. The student should be able to examine judgments and cases concerning the informed consent of the patient and the professional liability of health professionals.
