ASSESSMENT METHODS	Oral examination whose purpose is to verify due competences and the ability of personal synthesis concerning the program. The assessment is given in numbers (from 18 to 30). Students will have to answer orally at least two or three questions concerning the program and the texts suggested during lectures. Questions asked verify: a) acquired competences; b) ability of elaboration; c) the acquisition of adequate abilities of presentation; d) personal autonomy of judgment. Objective of the course is to provide students with knowledge of current methods nowadays used in modern schools of anthropology of language, particularly underlining the relation existing between the notions of language and culture. The course aims at providing students with adequate instruments concerning (i) language meant as an instrument of comprehension of cultures and (ii) culture meant as a linguistic device of organization. Specific fields studied will be linguistic identities and intercultural relationships in its constitutive forms established between power and knowledge, territories and linguistic representations, traditional heritage and linguistic innovation. Non-attending students, workers, or students with particular needs, may agree with the teacher for an alternative program.
