<p>PREREQUISITES</p>	<p>The overall aim of the course is to give students the opportunity to reflect and develop an understanding of the role of the language in migration both on a theoretical and practical level. This will be developed by acquiring a theoretical foundation that focuses the attention on the role of language a) as a barrier in communication, b) in the construction of resilience factors at the level individual, family and community</p> <p>UNDERSTANDING CAPACITY Students are able to link the main concepts of the course to linguistic and social processes. They are able to analyze i linguistic and social processes typical of migratory linguistics. <p>ASSESSMENT METHODS</p>	<p>For attending students: ongoing written tests (40%) + oral test (60%) in which the written work is discussed For non-attended students: oral test (100%) in which the recommended texts are critically discussed. The ongoing written tests consist of semi-structured questions in which to analyze particular aspects of the discipline through the analysis of case studies through scientific writing The oral test consists of an interview, aimed at ascertaining the possession of the disciplinary skills and knowledge required by the course. The discussion is based on the presentation of the case studies examined in the written paper. The evaluation is expressed in thirtieths. Description of assessment methods: 30 - 30 cum laude: a) excellent knowledge of the topics and critical understanding of the theories and principles of the discipline b) advanced ability to apply acquired knowledge and to analyze linguistic data c) excellent language and argumentation skills d) excellent ability to organize the subjects of study of the discipline in an autonomous and innovative way and to apply the knowledge for linguistic analyses. 26 – 29: a) Good command of the topics combined with critical awareness of analysis b) good ability to apply acquired knowledge and to analyze linguistic data c) good command of specialized language d) ability to organize the subjects of study of the discipline in an autonomous and innovative way. 22–25: a) basic knowledge of the main topics b) limited ability to apply methods, material tools and information autonomously</p>
