When student shows a general knowledge and understanding of course subjects and ability to face very simple practical cases. Below this threshold the exam is not passed. If the student shows a good knowledge and understanding of the topics covered, the evaluation will be able to reach 26/30. The more the student will show knowledge and understanding of the subjects and autonomy in applying them, the higher the mark will be, until 30/30 cum laude.</p>
