EDUCATIONAL OBJECTIVES OF THE MODULE

The course aims at providing students with an overall understanding of human rights rhetoric and structure. In particular the course will dwell on: the structure of human rights (foundations, right holders, duty holders, protected interests, content); the limits of rights; the interest and choice theory of rights; the moral/political justification of human rights; the philosophical and legal evolution of human rights (at the international level); individual and collective rights. A deeper understanding of the theoretical foundations of human rights will allow students to better handle the instrument/tool of human rights vis à vis real cases thanks to a better ability to frame (linguistically and theoretically) them and interpret the meaning and content of their legal recognition.
