DOCENTE: Prof. ANDREA COZZO good knowledge of the ancient Greek language, of the development of Greek **PREREQUISITES** cultural history, as well as of the main philological tools able to allow a critical reading of the texts. LEARNING OUTCOMES Knowledge and comprehension. The course aims to strengthen the skills matured in the preceding studies through the analysis of texts usually poorly attended during the three-year degree course. In particular it aims to know and understand social and ethical issues and philosophical-scientific topics, to be developed between the 15-hour option and the 30-hour option. The course begins with the collection of sources and bibliography. Capacity to apply knowledge and understanding Students will have to show the ability to understand the proposed Greek texts, by reading also its critical apparatus, to code them properly in Italian as well as to interpret them in terms of cultural history, along with the ability to personally process the collected data. Making judgments. Students will be able to process, in the reading of texts and essays made during the lessons and also through individual commitment, independent capacity of criticism. For this purpose a direct approach to the Greek texts will be always initially preferred, and only later will be proposed the bibliography study. The seminar structure aims to promote autonomy of critical judgment, through the analysis of the steps of the hermeneutical process, in which will be showed the historical determination. Communication ability. Students will be able to communicate with colleagues and the teacher during the lessons and during examination, the themes, contents and methods of the discipline by using correctly the specialized language. It is also required the ability to communicate the findings to non-specialists. Learning capacity. Students will reach knowledge of the contents and methods of the discipline, dealing with texts usually not studied during the three-year degree course, and must show aptitude also to the identification of independent and original research topics. They will also acquire skills to learn the method of scientific research, through the examination of the sources and the critical confrontation with the bibliography. Oral exam and written report. ASSESSMENT METHODS a) Excellent knowledge of the subjects, excellent verbal skills, good analytical capacity, the student is able to apply his knowledge to solve proposed problems: 30 - 30 cum laude. b) Good knowledge of the topics, full verbal skill, the student is able to apply his knowledge to solve proposed problems: 26-29. c) Basic knowledge of the main topics, guite good verbal skills, with limited ability to independently apply the acquired knowledge to the solution of the proposed problems: 24-25. d) does not have full command of the main teaching subjects but he has the knowledge, satisfactory language skills, unable to completely apply the independently reached knowledge: 21-23. e) minimum basic knowledge of the main teaching and technical language issues, very little or no ability 'to independently apply the acquired knowledge: f) does not have an acceptable knowledge of the contents of the topics covered: insufficient.

EDUCATIONAL OBJECTIVES OF THE MODULE

The 30-hours module aims to rebuild the Greek ethical thought of archaic and classical age in its relations with the social structures. After analysis of poets and thinkers of archaic age, the course will focus the Aristotelian ethical thought reading selected passages from the Nicomachean Ethics, which indicate the definition of virtue and the declination of the main virtues that the citizen must exercise within the polis.
